# **ICOMOS-UK AGM 2024**

# **Duties of Trustees**

### **Overall responsibilities of Trustees**

Trustees have control over, and legal responsibility for ICOMOS-UK's management and administration.

They must abide by the terms of the CIO governing document, act in ICOMOS-UK's best interests, manage its resources responsibly, and act with reasonable care and skill.

Trustees are appointed by, and are ultimately responsible to, the membership.

### **Ex-Officio** Trustees

Ex-Officio Trustees (the President, Vice President and Treasurer) take on specific roles as follows:

#### The President's main role is to:

- □ act as a figure-head and take the lead in ensuring that Trustees comply with their duties and the CIO is well governed;
- provide direction for the CIO and ensure that Trustees fulfill their duties and responsibilities for overall governance and strategic direction;
- □ help plan and run Trustee meetings and the AGM to ensure that they are properly run and recorded;
- act as a link between Trustees and staff and as a line manager for the CEO/Director on behalf of Trustees to ensure their decisions are acted upon and the organization is managed effectively.

He/she is automatically a member of the ICOMOS Advisory Committee that consists of Chairs of National and Scientific Committees. He/she is expected to attend, as a representative of ICOMOS-UK, annual meetings of the Advisory Committee and the ICOMOS General Assembly, as well as meetings of the ICOMOS Europe Group.

#### Vice President's main role is to:

□ support the President in carrying out his/her role;

- deputise for the President when requested to do so;
- □ leads on projects/work areas delegated by the President and Board.

## The Treasurer's main role is to:

□ review the CIO's financial performance and providing quarterly reports to the Trustees;

□ advise on policies for finance and investment;

□ ensure that the CIO has robust and effective financial controls in place;

□ liaise with staff and with the CIO's independent examiner;

□ report on financial matters to members at the AGM.

## **Obligations of Trustees:** Trustees

must:

- □ ensure that ICOMOS-UK's activities comply with its CIO governing document as well as with charity law requirements in carrying out its purposes for the public benefit;
- □ protect and safeguard ICOMOS-UK's assets and ensure that they are only used to support or carry out the purposes of the organisation;
- avoid exposing ICOMOS-UK's assets, beneficiaries or reputation to undue risk;
- $\Box$  not over-commit the CIO;
- □ ensure the CIO is appropriately accountable;
- □ oversee the development of the CIO's vision, mission, objectives and business plans;
- agree to support collective decisions of the Board and not dispute these publicly;

# Conflict of interest:

# Trustees must:

□ declare conflicts of interest of loyalty, not limited to financial interest.

# Requirements of Trustees:

- □ Elected Trustees, including ex-Officio Trustees, are usually elected for a three year term and are allowed to serve a maximum of three terms;
- □ Co-opted Trustees are usually co-opted for a one-year term;
- Trustees are normally requested to take a key role on some of ICOMOS-UK's work areas;
- □ When a Trustee is invited to represents ICOMOS-UK at an event or meeting, they should inform the Secretariat and ensure that they are speaking on behalf of the organisation.

# Time Commitment:

- □ Trustees are expected to attend the quarterly Executive Committee meetings, currently held virtually from 2-5pm. There are plans to hold two meetings onsite and two on line in the future. A hybrid version of a combination of online and on site attendances will be made available once technology facilities are available;
- □ Trustees are not reimbursed for travel costs related to attending meetings that may be held invenue;
- □ If more than three meetings are missed by a Trustee, other Trustees will consider requesting the Trustee to step down;
- It is expected that Trustees will attend the AGM to make themselves accessible to members;
- □ Trustees may be invited to lead sub-groups on particular projects, or topics for development and thus may require one or two additional meetings in London or another place, unless the sub-group members feel that they can arrange remote or 'virtual' meetings;
- Trustees are expected to attend one or two events of the events that ICOMOS-UK programmes each year to demonstrate support for staff and the event; events are mainly in London but may also be held in other areas of the UK;

- □ Trustees may be requested to make a presentation at an ICOMOS-UK event; it is ICOMOS-UK's policy not to pay a fee but speakers' travel expenses may be met;
- Occasionally ICOMOS-UK is invited to nominate expert speakers in particular specialisms of conservation practice for external events and Trustees may be asked if they wish to be nominated; Trustees may decline.
